I was flagged down at the intersection of Ponce De Leon and Okeechobee Blvd, in reference to the white male William Nordman attempting to get [REDACTED] [REDACTED]. Nordman was also making verbal threats to kill [REDACTED]

I arrived on scene and as I made my approach to the residence on foot I could see a shadow of a person on the north side of the above residence. I then saw a white male walk from the north side of the residence to the front of the residence. The white male later identified as William Nordman saw me and attempted to avoid me by walking towards the rear of the above residence. I identified myself as a Deputy and ordered him to stop. Nordman turned towards me and became belligerent. I displayed my taser in a soul position and ordered Nordman to prone out on the grass, Nordman was not complying with my verbal commands. I pointed my taser at Nordman and once again ordered him to prone out on the ground. Nordman replied "what if I don't" I answered I would Tase him. Nordman got on the ground but was still refusing to place his arms behind his back. I made several verbal commands for Nordman to comply and subsequently he did. I was able to place Nordman into handcuffs without incident.

I spoke to the complainant ██████████ who said that Nordman was intoxicated and possibly under the influence of some type of narcotics and is also Bipolar. Nordman becomes violent and has become physically violent with her in the past. The complainant said that Nordman has been arrested for domestic violence against her in the state of Tennessee, 2 times in 2016 and once in 2017. On this date Nordman was attempting to gain access into the above residence via the bedroom window. Nordman was telling the complainant to give him his cigerretts and that she had to give him money. When the complainant refused to do so Nordman verball said that he was going to " Take her Life". This was done in the presence ██████████. Nordman did not physically batter the complainant on this date.

I placed Nordman in the rear of my patrol car once inside Nordman verbally stated to me " your gonna get yours" you wait and see". Nordman also upon seeing the complainant became combative in the rear of the police car laying on his back and violently kicking the patrol cars window. Nordman subsequently calmed down without incident.
