


The following was captured on my BWC:

On Saturday, April 14, 2018, at 1951 hours, I responded to 141 E Riverside Dr. Apt 10A in reference to a battery that had just occurred. The caller/witness Shannon Sitarik (W/F 06/19/1972) reported that her neighbor/suspect William Eaton (W/M 2/27/82) knocked on the door of her apartment and asked for her friend and Eaton's ex-girlfriend/ victim Maureen Gargiulo (W/F 7/4/83) to come to the door. When Gargiulo came outside to the patio to see what he wanted from her, he punched her in the right side of her face. The punch caused her to fall back into a potted plant and knocked her out. S. Sitarik then said that Eaton said "that was in self defense, she hit me first". She said at no point did she ever see Gargiulo hit him before or after. S. Sitarik advised that her daughter Bella Sitarik (W/F 2/20/06) was also present during the entire encounter. Eaton then drove off in a grey Infiniti bearing FL tag # IGMK99, before 911 was called.

I then made contact with victim Gargiulo who was on the patio still and icing her side. She had a visible red mark on the right side of her face with slight swelling, her right side rib cage had blood blisters and red marks and her right elbow was bleeding and scraped. She declined fire rescue coming in to treat her injuries. Gargiulo reported that Eaton is her ex-boyfriend since breaking up in October 2017 and have no children in common. Eaton is upset that she is now friends with S. Sitarik. She was using the bathroom in the apartment and she was advised that Eaton was out on the patio asking for her. She walked out there and asked what he needed to speak to her about. He mentioned a voicemail, but she did not know what he was referring to. She said he walked towards her with his chest up, like he was going to hurt her. She put her hands up as he was getting closer, to guard herself and told him to not touch her. He then punched her in the right side of the face, causing her to fall into the planter, which caused the above injuries. She advised the touching was not wanted and that she would like to press charges against him for battery. She was issued a Victim's Rights Brochure. Close ups of


the injuries were taken with the BWC.

I received permission from S. Sitarik to speak to her daughter B. Sitarik about the incident. B. Sitarik told me that she watched Eaton buff up at Gargiulo like he was going to hurt her. Gargiulo put her hands up to block him and she said "don't hurt me". Eaton then punched her in the face and she fell into the planter. Her mother S. Sitarik then made him leave and on his way out he pushed items off of the patio table.

The area was patrolled for Eaton or his vehicle and he could not be located. The vehicle was brought back to the residence by a female friend eventually and she informed officers that he may be found at the Jupiter Lighthouse. I patrolled the lighthouse and he was not located at the time. We went out multiple times to the residence through the night, but contact could not be made.

The above circumstances gave me probable cause to charge Eaton with simple battery because Eaton did actually and intentionally touch or strike Gargiulo against the will of Gargiulo {or} did intentionally cause bodily harm to Gargiulo, contrary to Florida Statute 784.03(1). (1 DEG MISD).
