On Saturday the 7th day of December, 2019, at approximately 1645hrs I arrived at Kohls (1901 N. Congress Ave.) in reference to a call for service regarding a retail theft. Upon my arrival I met with the business's loss prevention specialist (Arthur Pezek) who advised he observed two females, later identified as Yamelis Fuentes Salgado and Yamile Fuentes Fumero, stealing from the business; to be noted that at the time of my arrival, both Yamelis and Yamile were still within the dressing room.

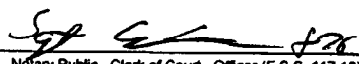
Arthur provided me with a sworn verbal statement which was captured on my AXON body worn camera; captured at the approximate 21min mark of the cameras recording. In this statement, Arthur advised that he wanted to press charges on behalf of the business (Kohls) and would be willing to testify in court if given the opportunity.

Arthur went on to say that he observed the females within the Mens Athletic Department selecting numerous articles of clothing and wrapping them up before placing them in the shopping cart they were sharing. Arthur advised that this behavior is indicative of someone preparing to steal as it conceals the items within the cart. After clearing the Mens Athletic Department, both Yamelis and Yamile then went to the Kids Shoe Department where they removed children shoes from the boxes, then placing the shoes in the cart and leaving the boxes behind; there would be no way to ring the shoes up at the register as the barcodes and price tags are affixed to the box and not the shoes.

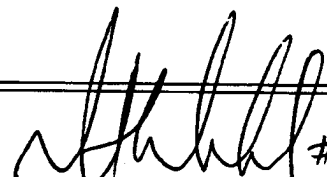
After leaving the Kids Shoe Department, both Yamelis and Yamile then made their way to the Intimate Departments dressing room; I arrived just after Yamelis and Yamile both entered the SAME dressing room. Upon their departure I asked them to wait for a moment while Arthur checked the fitting rooms at which time he found numerous defeated security devices and tags that had been discarded within. Yamelis and Yamile were then escorted to the loss prevention office where the items they had previously selected were now recovered from within their respective purses.

Yamelis had \$207.99 worth of merchandise (clothing) within her purse while Yamile had \$201.00 worth of merchandise (clothing) within her purse; all of which was recovered at no loss to the business. An itemized copy of the receipt was obtained and will be submitted with this report. To be noted, that while recovering the merchandise from Yamelis's purse a retail anti-shoplifting device, a large circular device used to deactivate the security tags, was located in her purse. Also to be noted that Yamelis and Yamile BOTH had concealed items on their person that required the use of this described device to deactivate the respective security measures.

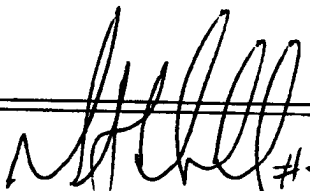
Based on the above facts, I find it more probable than not that both Yamelis and Yamile were depriving the business (Kohls) of the full retail value of the merchandise concealed. I find probable cause to charge BOTH Yamelis and Yamile with Retail Theft in accordance with F.S.S. 812.015 as well as Possession / Use of the Anti-Shoplifting Device in accordance with F.S.S. 812.015 (7). After being cleared of having any active wants or warrants, Yamelis and Yamile were both transported to the B.B.P.D. for processing and their care and custody was later turned over to the Palm Beach County Jail. A digital copy of the video surveillance was obtained and will be submitted into the B.B.P.D. digital evidence database (A.D.A.M.S.) via the remote program digital acquire.

Prior to leaving the business, Yamelis and Yamile were both trespass warned by Arthur, this occurring at the approximate 30min mark of my AXON body cameras recording. Yamelis and Yamile both stated that they understood that if they are to return to the business within a period of one year that they will be subject to arrest for trespassing after warning. The anti-shoplifting device recovered will be submitted into B.B.P.D. Evidence as such.
