PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

While traveling southbound on East Main Street within the City of Pahokee, Palm Beach County Florida I observed a black Chevrolet Silverado Truck bearing Florida Tag "EBDN77" that was swerving over the painted yellow double line separating the North and South travel lanes. The truck then crossed over the center line as a small dark colored compact car was approaching from the South. As the truck approached the posted Stop Sign located at the intersection of East Main Street and North Lake Avenue the truck failed to stop prior to the painted solid white Stop bar prior to the crosswalk area. The truck then turned in a Westbound direction going into the Pahokee Marina located at 190 North Lake Avenue. Fearing the pedestrian traffic in the area I initiated a traffic stop based on the above described traffic infractions. Prior to the vehicle coming to a stop it swerved aggressively from left to right several times causing the truck to sway and tip side to side.

OBSERVATION OF DRIVER:

Upon approaching the driver side door of the black Chevrolet Silverado I observed a white male, the sole occupant of the vehicle, in the driver seat with the engine running. As I came along side the driver door the subject located in the front driver seat lit a cigarette and began smoking it. I observed a large clear cup located in the cup holder that is integrated with the center console portion of the truck with an amber colored liquid filled approximately three fourths full. Prior to my speaking the driver stated "I'm sorry". I detected a strong odor of an unknown alcoholic beverage coming from on or about his person. The odor would intensify greatly each time the driver spoke. His eyes were bloodshot, glossy and his eye lids were partially open. I informed the driver that I was stopping him due to his swerving into the oncoming lane for failing to make a proper complete stop. The driver responded "I know I'm sorry." I asked the driver for his license registration and insurance. The driver opened up the upper compartment located in the middle of the truck typically used for the storage of sunglasses and produced multiple folded up documents and studied them for a moment then asked permission to put them back. I advised him he could and repeated the request for License, Registration and Insurance. The driver stated that his license was in his wallet and asked permission to exit the vehicle in order to retrieve his wallet. I allowed him to exit the vehicle. When he exited he was unsteady on his feet and used his right hand on the open door interior as well as his left hand on the truck to steady himself. He felt his back pocket and said "shit my wallet is in the truck can I get it?" I allowed him to retrieve his wallet. He opened the wallet and began removing multiple credit cards from various locations. He made the statement "I have two Licenses and handed me an identification that is issued by the Transportation Safety Administration known as a "Transportation Worker Identification Card". I informed him again that I needed his Driver License which he then produced. He was then identified as Yann Berard (06/29/1981). I stepped away to conduct a wants and warrants check and when I returned Berard stated "oh shit." I asked if he would submit to roadside tasks to evaluate his ability to operate a motor vehicle and he agreed. As I had Berard move to the front of my marked patrol car Berard began walking towards a concrete wall and I had to redirect him to follow me. Berard stated "he went the other way but ok." and followed me to the front of my vehicle. As he walked he was unsteady on his feet and was not able to walk in a straight line towards me. Also when asked to stand still he would sway in a circular fashion and would lean forward multiple times where he would have to take a step to catch his balance and prevent himself from falling.

DRIVER'S STATEMENTS:

Prior to arrest: "I'm sorry" / "I've been drinking" / "I'm a good guy" / "I can't believe you are doing this to me."

Post arrest: "fuck you" / "your kids and my kids might play soccer together and you're going to do this to me?" / "the last time I killed a deer was, I don't know, a long time ago."

ODORS:

Odor of an Unk Alcoholic beverage coming from his person which intensified greatly each time he spoke.

GENERAL OBSERVATIONS

SPEECH: Slurred speech, low in volume, difficulty forming and then expressing a complete thought

ATTITUDE: lethargic, difficulty following instruction, difficulty answering basic questions, would interrupt and attempt multiple times to tell me what task he was going to perform next.

CLOTHING: t shirt and blue jeans, jeans zipper was partially unbuttoned, belt was not securely fastened and pants were off center in a disheveled state

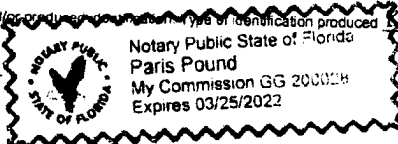

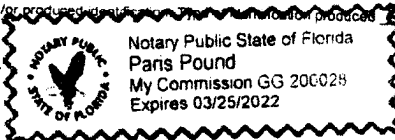

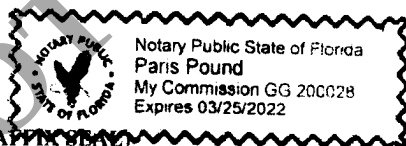
