PERSONAL CONTACT

NARRATIVE:

On March 3rd, 2018 at approximately 10:13 PM I was dispatched to 2388 Kirk Road Palm Springs, FL 33461 in reference to a call to 911 (open line) with the audible sound of a female crying in the background. Upon arrival I knocked several times on the front door of the residence with no success contacting the resident(s). The garage of the residence appeared to be made into an efficiency that contains one room and a bathroom. PSPD dispatch called the phone again (561-410-2896) and made contact with a female later identified as Lianys Cordero by her FL driver's license. Cordero told PSPD she was stepping outside and I met her by the gate to the fence located just south of the front door.

Cordero appeared upset, was crying and breathing heavy. Cordero's primary language is Spanish but I was able to communicate with her in English. Ofc. Ferrer #159 arrived shortly after to aid in English/Spanish translation and Cpl. Fequiere #115 arrived on scene as a back up officer / supervisor. While talking to Cordero, I observed red marks on her neck and one red mark on her chin. The marks on her neck resembled a similar pattern to the necklace she was wearing as if force was used to press her necklace against her neck. I asked Cordero what happened and she stated she was in an argument with her boyfriend, later identified as Yansel Jimenez Blanco by his FL driver's license, over relationship issues. Cordero stated she has been in an intimate relationship with her boyfriend for approximately one and a half years and that live they together. Cordero told me she threatened to leave Jimenez Blanco, he became upset and pushed her by her neck which caused her to fall onto the bed. Cordero said she called 911 after she was pushed and Jimenez Blanco apologized for his actions. Cordero told me I arrived shortly after the call to 911 was placed.

After talking to Cordero briefly, Jimenez Blanco stepped out of the residence and met with me in the driveway. I talked to Jimenez Blanco by using Ofc. Ferrer for translation. Ofc. Ferrer read Jimenez Blanco his Miranda Rights using a PSPD Spanish Miranda Rights Card. Jimenez Blanco told me he has a wife and child in Cuba but is in a relationship with Cordero in the United States. Jimenez Blanco said he has been in an intimate relationship with Cordero for approximately one and a half years. Jimenez Blanco told me Cordero became jealous and upset when he called his wife in Cuba. After the phone call, Jimenez Blanco said Cordero charged at him in the bedroom out of rage by walking in a fast pace in his direction. He stated he pushed her by her shoulders onto the bed. I asked him how Cordero got the marks on her neck and chin but Jimenez Blanco stated he did not know and denied causing the marks. I asked Jimenez Blanco if Cordero made any threats to harm him and he said "no". Jimenez Blanco only believed Cordero was going to hit him because of her demeanor and pace toward him. Jimenez Blanco stated that he received a scratch mark on the right side of his stomach during the altercation. Jimenez Blanco was detained by being placed in handcuffs behind his back, the handcuffs were checked for proper spacing and were double locked.

When Cordero observed Jimenez Blanco being detained she changed her story and said she charged at Jimenez Blanco, "couldn't live without him" and did not want him arrested. Jimenez Blanco and Cordero both refused to provide me with a video/written statement describing the incident. I took photos of the crime scene, pictures of the injuries on Cordero and turned it into PSPD evidence along with the PSPD Miranda Rights Card read to the defendant. Jimenez Blanco refused when I asked to take pictures of the scratch marks on his stomach. I transported Jimenez Blanco to PSPD after advising him of his charge of battery, filled out arrest paperwork and then transported him to the Palm Beach County Jail where he was turned over to correctional staff. Both Cordero and Jimenez Blanco admitted to consuming alcohol prior to my arrival and appeared intoxicated (blood shot eyes, heavy odor of alcohol on breath, loud voice).

DEFENDANT'S STATEMENTS: (Written / Taped / Oral)

Stated he was in an argument with victim, pushed her by her shoulders when she charged at him and that the argument was caused over jealousy. Defendant stated he was drinking alcohol prior to my arrival.

VICTIM'S STATEMENTS: (Written / Taped / Oral):

Victim stated defendant pushed her by her neck onto the bed which caused red marks on her neck. Later she stated she charged at the defendant and that the incident was her fault. Victim stated she was drinking alcohol prior to my arrival.

OBSERVATIONS OF VICTIM (PHYSICAL AND EMOTIONAL)

Victim was crying, appeared upset and was breathing heavy. I observed marks on her neck and chin.

RELATIONSHIP BETWEEN VICTIM AND SUSPECT: Intimate relationship Boyfriend/Girlfriend for approx. 1 1/2 years & live together.
