DRIVING PATTERN:

ON 07/21/18, AT APPROX 11:03 P.M., I WAS DISPATCHED TO A VEHICLE VS. PEDESTRIAN CRASH AT 3189 FOREST HILL BLVD., PALM SPRINGS, FL. I ARRIVED ON-SCENE AND SAW THE PEDESTRIAN IN THE ROADWAY WITH WHAT APPEARED TO BE POTENTIALLY FATAL WOUNDS TO THE HEAD AND CROTCH AREA. A WITNESS, ROMANS SYLVESTER III, SAW HE SAW A TRUCK THAT APPEARED TO BE THE ONE STOPPED IN A NEARBY PARKING LOT, TRAVELING ABOUT 40-45 MPH WEST ON FOREST HILL BLVD. WHEN THE TRUCK COLLIDED WITH THE PEDESTRIAN AS THE PEDESTRIAN WALKED SOUTH ACROSS THE ROAD IN AN AREA THAT WAS NOT DESIGNED FOR CROSSING. SGT. HILLERY SPOTTED A 2012 BLACK DODGE TRUCK BEARING FLORIDA LICENSE PLATE Z81FAV. THE TRUCK APPEARED TO BE THE TRUCK INVOLVED BECAUSE IT MATCHED THE DESCRIPTION OF THE VEHICLE INVOLVED AND HAD LEFT FRONT END DAMAGE. SGT. HILLERY SAW THE TRUCK IN THE EAST BOUND LANES A FEW HUNDRED FEET WEST OF THE WHERE THE PEDESTRIAN. SGT. HILLERY PULLED BEHIND THE TRUCK AS IT PULLED INTO THETOM SAWYER RESTAURANT AT 3208 FOREST HILL BLVD. SGT. HILLERY MADE CONTACT WITH THE DRIVER WHILE HE WAS STILL BEHIND THE WHEEL AND IDENTIFIED HIM AS YOLEXY CUELLAR PEREZ. THE PEDESTRIAN WAS TREATED BY THE PALM BEACH COUNTY FIRE RESCUE. SGT. HILLERY ATTEMPTED TO OBTAIN ASSISTANCE FROM PBSO AND FHP. WE RECEIVED NOTIFICATION THAT THE PEDESTRIAN BECAME DECEASED ABOUT AN HOUR AFTER THE CRASH. I WAS NOTIFIED BY SGT. HILLERY AFTER A FEW HOURS THAT THERE WOULD BE NO ASSISTANCE FROM PBSO OR FHP AND THAT HE WANTED ME TO MOVE FORWARD WITH REQUESTING BLOOD FROM THE DRIVER DUE TO THE CRASH AND SIGNS OF IMPAIRMENT. PALM BEACH COUNTY FIRE EMS#91 (RUN#PBC18078985) RESPONDED TO OUR LOCATION. LAKE CLARKE SHORE OFFICER LOIACONO #26 AND THE DEFENDANT ENTERED THE REAR OF THE AMBULANCE. PARAMEDIC HIRSCH #18554, PARAMEDIC SHIPLEY #18442, FIRE CAPT ISLER #10187, AND I ALSO ENTERED THE AMBULANCE. MY IN-CAR CAMERA WAS RECORDING. OFFICER LOIACONO ASSISTED WITH SPANISH/ENGLISH TRANSLATION. I INFORMED THE DRIVER THAT I WAS NOW CONDUCTING A CRASH INVESTIGATION. THE DRIVER SAID HE UNDERSTOOD. I REQUESTED THE DRIVER SUBMIT TO A LAWFUL TEST OF HIS BLOOD BY READING THE IMPLIED CONSENT FOR DUI FORM. THE DRIVER REFUSED CONSENT. I READ THE IMPLIED CONSENT LAW TO THE DRIVER AND AGAIN REQUESTED THAT HE SUBMIT TO A BLOOD TEST. THE DRIVER REFUSED TO SUBMIT. I READ THE MIRANDA RIGHTS TO THE DRIVER. THE DRIVER SAID HE UNDERSTOOD HIS RIGHTS. THE DRIVER ADMITTED TO CRASHING INTO THE PEDESTRIAN WITH HIS VEHICLE. THE DRIVER SAID HE DID NOT DRINK AN ALCOHOL AND MAINTAINED THIS, EVEN AFTER CONFRONTED WITH HIS SIGNS OF IMPAIRMENT. THE DRIVER WAS THEN TRANSPORTED TO THE PALM SPRINGS POLICE DEPT. FOR BOOKING.

ADDITIONAL: THE DRIVER USED HIS TRUCK TO LEAN ON WHILE WAITING. THE DRIVER WALKED VERY DELIBERATE AS IF TRYING TO WALK NORMAL. THE DRIVER SPOKE SPANISH AND ENGLISH WITH A SLIGHT SLUR AT TIMES. THE DRIVER APPEARED NERVOUS AS HE KEPT GOING OVER WHAT HAPPENED WITH HIS AUNT AND UNCLE. THE DRIVER WAS TOLD TO NOT DRINK ANYTHING AT THE TIME AND HE KEPT TRYING TO SNEAK SOME WATER TO DRINK. THE DRIVER GRABBED THE WATER AT ONE POINT AND DRANK SOME OF IT AFTER BEING TOLD NOT TO DRINK ANYTHING. I COULD SMELL A VERY STRONG ODOR OF AN ALCOHOLIC BEVERAGE ON THE DRIVER'S BREATH. THE DRIVER WAS CHEWING GUM. THROUGH MY EXPERIENCE AND TRAINING I HAVE LEARNED THAT DUI DRIVER'S WILL CHEW GUM IN AN ATTEMPT TO CONCEAL THE ODOR OF AN ALCOHOL BEVERAGE.


