L	<p>Upon arrival, I observed Taborda near the door to Apartment 7. I asked her to come to my position and sit in a chair by the pool. She complied, but had trouble walking straight due to her level of intoxication. Taborda had trouble speaking clearly and her words were extremely slurred. She had red, bloodshot eyes, and the odor of an alcoholic beverage emitting from her face and mouth area. She said her daughter locked her out of the home but did not know why. Taborda had a small scratch on her left forearm but refused medical attention.</p>

S	<p>I made contact with Zapata inside apartment 7. She said her mother was drinking throughout the night and refused to go to sleep. Zapata attempted to convince her mother to sleep but she refused. They entered into a verbal altercation that quickly escalated. Zapata turned away from her mother in an attempt to defuse the situation. Taborda called Zapata "disrespectful", reached out with her left arm and grabbed a handful of Zapata's hair. Zapata said she pulled so hard it jerked her head back. Zapata reached back and pulled her mother's hands from her hair, leaving a small scratch on Taborda's left forearm. Zapata's hair was disheveled and had obviously been pulled recently. Zapata refused medical attention.</p>
