Boca Raton Police Dispatch received a call from Daniela Zapata, the daughter of Yulieth Taborda, who stated her mother was intoxicated and arguing with her. She also said she locked her mother out of the home because she was concerned due to her level of intoxication.</p> <p>Upon arrival, I observed Taborda near the door to Apartment 7. I asked her to come to my position and sit in a chair by the pool. She complied, but had trouble walking straight due to her level of intoxication. Taborda had trouble speaking clearly and her words were extremely slurred. She had red, bloodshot eyes, and the odor of an alcoholic beverage emitting from her face and mouth area. She said her daughter locked her out of the home but did not know why. Taborda had a small scratch on her left forearm but refused medical attention.</p> <p>I made contact with Zapata inside apartment 7. She said her mother was drinking throughout the night and refused to go to sleep. Zapata attempted convince her mother to sleep but she refused. They entered into a verbal altercation that quickly escalated. Zapata turned away from her mother in an attempt to defuse the situation. Taborda called Zapata "disrespectful", reached out with her left arm and grabbed a handful of Zapata's hair. Zapata said she pulled so hard it jerked her head back. Zapata reached back and pulled her mother's hands from her hair, leaving a small scratch on Taborda's left forearm. Zapata's hair was disheveled and had obviously been pulled recently. Zapata refused medical attention.</p> <p>Taborda was placed under lawful arrest pursuant to FSS 784.03(1A1) Battery (Domestic) after she did actually and intentionally pull Zapata's hair against her will. She was then transported to the Palm Beach County jail without incident.</p>
