PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I observed a black Toyota Tundra bearing Texas tag GBZ-9949, a pickup truck stopped at steady green traffic signal, located at southbound N. Military Trail and Southern Blvd. I exited my patrol vehicle and observed the driver was asleep. The vehicle was in drive and the drivers foot was on the brake. The vehicle was unlocked. I then opened the driver door and turned the vehicle off. I also removed his semi automatic pistol that was attached under the steering wheel for safety. I then woke the driver. He was drooling and the odor of an unknown alcoholic beverage was emitting from his person. As I spoke to him and asked him why he was sleeping. He responded with mumbles and appeared to be disoriented. He was then identified by his Florida DL as Yuri Yelandy Sierra Vazquez. He was the sole occupant of the vehicle.

OBSERVATION OF DRIVER:

I observed that Sierra-Vazquez was wearing black tank top shirt and black/gray jean shorts. While questioning Sierra-Vazquez, I observed that he seemed to be confused by my questions, he continued to mumble about having to go to work. I had to make him exit the vehicle driver seat because when asked, he would not get out of the vehicle. Once out of the vehicle, Sierra-Vazquez attempted to resist by pulling his arms and body away, but was quickly escorted to the side of his vehicle without incident. I observed Sierra-Vazquez eyes appeared red and glassy. I observed that he was slurring his words. Sierra-Vazquez was asked to perform field sobriety tasks and he refused. With the assistance of Deputy Sierra ID# 7661 for Spanish Translation. While conducting HGN, Sierra-Vazquez swayed heavily from side to side and front to back. Sierra-Vazquez had a difficult time keeping his eyes on the red light stimulus.

DRIVER'S STATEMENTS:

I asked if the driver had been drinking or used any drugs, he said that he only had a little to drink. I asked the driver what medical problems and/or previous injuries they had, he said he had none. He does not wear glasses or contacts. I asked what medications they take, he said none.

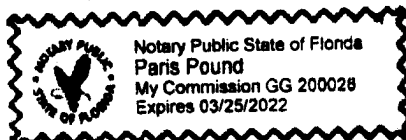

Other Observations:

Once positioned in the front of my vehicle, I continued my investigation. I instructed Sierra-Vazquez to keep his hands by his side, stand with his feet together, and follow a red light stimulus with his eyes not turning his head. I asked him if he understood my instructions. Sierra-Vazquez verbally stated he understood my instructions. Sierra-Vazquez however swayed while standing stationary. I observed both eyes to be red, bloodshot, and glossy. His left and right eye displayed equal pupil size, equal tracking, and a lack of smooth. I observed distinct and sustained nystagmus was present in both his left and right eye at maximum deviation during two separate four second evaluations. The onset of nystagmus was prior to a 45 degree angle in both his left and right eye during two separate four second evaluations. Vertical nystagmus was not present in both the left and right eye during two separate four second evaluations. While conducting the task I had to remind him to keep hands by his side, not turn his head and follow the stimulus multiple times.
