I was in the area of Royal Palm Beach Boulevard and Lake View drive traveling West bound on Okeechobee Boulevard when a silver Subaru passed my vehicle in excess of 40 MPH in which I was traveling at 40 MPH at this time. I pulled behind this vehicle and paced this vehicle from my location to Okeechobee Boulevard and Crestwood Boulevard. I paced this vehicle at 57 MPH but maintained 55 MPH in a 40 MPH posted zone. I conducted a traffic stop on Okeechobee Boulevard and Crestwood. I made contact with a white male driver who identified himself by Florida driver license as Zachary Thomas Willey Hallman. At this time, the front passenger side window was down and I could smell an odor of alcohol coming from inside of the vehicle. I asked Zachary for vehicle registration and insurance. I noticed his hand movements were very slow and when he spoke I could smell a strong odor coming from his breath. His speech was also slow and slurred. I then looked at his eyes, which were glassy and watery. I asked if Zachary had been drinking tonight and he replied "I had a few drinks earlier". This statement was captured in audio during the in car video was recording. Zachary stated he was coming from Clematis and was going home. At this time, I called for a DUI unit and DUI unit 17 responded to the traffic stop. At this time, the traffic stop was transferred to DUI 17 G. Lynch # 8568

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 8/1/18 I responded to Okeechobee Blvd/ Crestwood Blvd, in Palm Beach County, in reference to a traffic stop with a possibly impaired driver. Upon arrival I met with D/S D. Smith id 15521, who conducted the traffic stop.

D/S Smith advised me that while on routine patrol he observed a silver Subaru car, bearing FL tag 475RAH traveling west on Okeechobee Blvd. While he was traveling 40mph the vehicle passed his marked patrol car at a high rate of speed. D/S Smith got behind the car and paced the car traveling at between 55-57mph in the posted 40mph zone. The car continuously varied in speed and could not maintain a steady speed. D/S Smith then conducted a traffic stop for the infractions at Okeechobee Blvd/ Crestwood Blvd. D/S Smith made contact with the driver, Zachary Hallman, the sole occupant of the vehicle. D/S Smith immediately noticed a strong odor of an unknown alcoholic beverage coming from the vehicle. Hallman's movements were slow and lethargic and his speech was slow and slurred. Hallman's eyes were glassy and Hallman stated that he had a few drinks earlier.

### OBSERVATION OF DRIVER:

I made contact with Hallman, who was sitting in the driver seat of his car. I immediately noticed that Hallman's eyes were glassy and there was a strong odor of a unknown alcoholic beverage coming from the vehicle. I had Hallman exit his car and stand in front of my patrol car. I noticed that Hallman's movements were slow and uncoordinated and there was a strong odor of a unknown alcoholic beverage coming from his breath, which got stronger when he spoke. Hallman appeared to be unsteady while standing and swayed while standing still. Hallman stated that he was coming from downtown West Palm Beach where he had been drinking and stated his last drink was approximately 1 hour ago. Hallman stated that he did not remember how many drinks he had but it was more than 1 and less than 10. Based on my observations and Hallman's admission to drinking I asked Hallman to perform standard field sobriety tasks, to which he complied.

### DRIVER'S STATEMENTS:

Hallman stated that he had been drinking approx 1 hour prior to driving. Hallman could not remember how many drinks he had but advised it was more than 1 but less than 10.

### ODORS:

STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE COMING FROM SUBJECT'S BREATH.



**Other Observations:**

Hallman was asked to stand with his feet together and place his hands by his sides. Hallman was asked to focus on the stimulus and follow it with his eyes. Hallman was told not to move his head to assist in following the stimulus. Hallman showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation and onset of Nystagmus prior to 45 degrees in both eyes. Hallman swayed while performing this task and had to be reminded not to move his head several times.

**WALK & TURN:**

Hallman was placed in the instructional stance for the walk and turn task. I utilized yellow tape to make a straight level line, free of debris, which Hallman advised he could see. I explained and demonstrated the task to Hallman. During the instructions Hallman was unable to maintain the instructional stance and stepped out of the position several times. Due to Hallman being unable to maintain the position I had him stand normally while I explained the instructions. After explaining and demonstrating the task Hallman advised he understood and had no questions. During the task Hallman did not walk heel-to-toe on any step and Hallman stepped off the line several times. Hallman used his arms for balance and did not turn as instructed. After turning Hallman paused to steady himself.

**ONE LEG STAND:**

Hallman was placed in the instructional stance for the one leg stand task. I explained and demonstrated the task to Hallman twice. After explaining and demonstrating the task Hallman advised he understood and had no questions. During the task Hallman swayed and used his arms for balance. Hallman put his foot down several times prior to 30 seconds elapsing. Hallman had to be reminded to keep his arms down at his sides and to look down at his raised foot. Hallman also had to be reminded to count aloud and he did not count as instructed.

**FINGER TO NOSE:**

Hallman was placed in the instructional stance for the finger to nose task. I explained and demonstrated the task to Hallman. After explaining and demonstrating the task Hallman advised he understood and had no questions. During the task Hallman missed touching the tip of his nose several times. Hallman attempted to use the wrong hand on the third right command. Hallman swayed throughout the task and while his eyes were closed I noticed his eyelids flutter.

**ROMBERG ALPHABET:**

Hallman was placed in the instructional stance for the Romberg alphabet task. I explained and demonstrated the task to Hallman. After explaining and demonstrating the task Hallman advised he understood and had no questions. During the task Hallman swayed, more than 2 inches. Hallman incorrectly recited the alphabet, making several errors. Again while Hallman's eyes were closed I noticed his eyelids flutter.


