Probable Cause

Defendant was driving eastbound on Palm Beach Lakes Bv approaching SR-9. I was the third vehicle coming off of the southbound exit ramp. When my light cycled to green, the defendant had not yet entered the intersection. The second car ahead of me was across the westbound lanes when the defendant crossed the stop line. I followed defendant as he turned northbound onto SR-9. I noticed defendant was faster than traffic around him. As I accelerated to overtake, I activated my radar, and I was immediately behind defendant I clocked him at 80 mph in a posted 65. Defendant stopped on the right shoulder for my emergency lights.

I approached the passenger side of the silver 2004 Nissan Sentra, FL tag Y25MLC. When defendant rolled the window down, there was a strong odor of black ice air fresheners. I could see two were opened. I could still smell a pervasive odor of raw marijuana. Defendant presented a FL DL. I had him come out of the car and secured him with handcuffs, then secured him in my car. I then conducted a search of the car. I found a read backpack on the right rear seat. I found three clear plastic bags, labeled by brand and weight of suspected marijuana. I also found 11 vials of THC oil and a yellow pill bottle with the label torn off with 3 and two partial Alprazolam tablets. I also found a small portable electronic scale and a "vape" electronic pipe used for smoking oils. There was also a loaded Ruger .38 0 cal semi-automatic pistol in a soft holster in the same compartment as the marijuana and oils.


Steve's towed the car. All evidence was seized and submitted to the Lantana TSF. The pistol was submitted for safekeeping.
