Per witness, Carla Atkins (08/11/1970 b/f), she observed the subject driving north bound in the outside lane of the 2300 block of Broadway at a high rate of speed. The vehicle was observed crossing lanes without the use of an indicator. The vehicle then drove onto a positive median and collided with a palm tree.

OBSERVATION OF DRIVER:

Upon arrival, Officer Wright observed the subject slumped over in the driver seat of the vehicle. Subject was breathing, yet unresponsive. Approximately five minutes after contact, the subject woke up. During the Field Sobriety Testing, officers observed an onset of Nystagmus prior to 45 degrees in both the left and right eye.
