The following incident was captured on my body worn camera.

On 02/11/18, at approximately 2029 hours, I was dispatched to 3300 Via Royale Apt. 3301, in reference to a suspicious incident. The caller, WF Brandi Jean Lyew Fong (09/07/95), stated WM Zachary Salzer (08/22/92) was extremely intoxicated and threatened to kill her pet rabbit. Fong explained to North Communications that Salzer has threatened to kill himself in the past and has been depressed of late. While on the phone with Salzer, Fong said he told her to go kill herself.

I arrived at 3300 Via Royale and parked approximately fifty feet south of Apt. 3301, waiting for a backup officer. The caller was not in the apartment and advised Salzer should be by himself. Fong wished to remain anonymous and wanted to meet with officers near the front entrance of Floresta off of Pennock Lane. As I was waiting for Fong to arrive, I observed a white male run west through the neighborhood. At this time, I didn't know the male was Salzer. Fong arrived and I began speaking with her. Her friend, WF Ariel Jones (01/28/97) was with her. Fong stated she wanted to remain anonymous because she didn't want to upset Salzer and it appeared as if she feared him. She was very shaken up and appeared nervous about the situation. She stated he would be very aggressive if he knew she called the Police. Fong said that Salzer is her current boyfriend and he was not acting normal tonight.

As I was speaking with Fong, she stopped talking, looked behind me, and said, "That's him." I turned around and observed Salzer walking east on the sidewalk. He was wearing sunglasses and it was clearly dark outside. He stopped and stared at us. Based on him possibly killing a rabbit, being extremely intoxicated, and possibly harming himself and/or Fong, I needed to speak with him. I felt it was my duty to evaluate Salzer and make sure he was not going to harm himself or anyone else. As I spoke to him, I realized he was the male who I saw running earlier. After I told Salzer that I needed to speak

with him, he put his hand out to me, and said "relax." He told me I was a Police Officer, which was clear, as I was wearing a marked Jupiter Police patrol uniform. At this point, he balled up his right fist. I told him to sit on the curb and he didn't comply. I told him if he didn't listen and sit on the curb, he would go to jail for resisting without violence. He still did not comply with my lawful order. Salzer pulled his right arm back and reached near his hip, as if he was grabbing a gun or a weapon. He had not been searched or patted down. I was very close to him and retreating was not practical. Fearing he was going to grab a weapon and his bizarre behavior, I pushed him backwards into an electrical box. He violently and aggressively pushed his arms upward and grabbed my vest. I pressed his body up against the electrical box and then rolled him over my right shoulder. He landed on the sidewalk and I grabbed his left arm. Sergeant Bujnowski arrived on scene and attempted to grab his right arm. Salzer refused to give us his right arm and kept it underneath his chest. Both Sergeant Bujnowski and I gave Salzer clear verbal commands to stop resisting and to give us his right hand. We did not know if he had anything in his right hand because it was not visible. He began laughing and saying he lived here. Sergeant Bujnowski removed his department issued X2 Taser and pressed it on Salzer's back. He told Salzer if he did not give us his right hand, he was going to be Tased. At this point, I was able to grab his right hand and place it behind his back. I secured Salzer by applying handcuffs to both wrists and behind his back. Salzer became extremely verbally abusive, cursing and calling us obscenities. Salzer was dripping sweat and continued to yell and scream during my entire contact with him. I detected an odor of an unknown alcoholic beverage emitting from Salzer, which became stronger as he spoke to me. Salzer was clearly intoxicated and created a disturbance while in custody. I noticed neighbors were coming out of their homes and looking through their windows, as they heard Salzer screaming.

Fong came back and stated she could not get into the residence because it appeared that Salzer broke the door. I asked if she witnessed the incident and she said no. Fong advised once I began speaking with Salzer, her and her friend ran back to check on the rabbit. I transported Salzer to the Jupiter Police Department for completion of booking paperwork. He was later transported to the county jail without incident.

Based on statements, evidence, and my investigation, I find probable cause to believe that Zachary Salzer knowingly and willfully resists, obstructs, or opposes I, a Police Officer, in the lawful execution of a legal duty, by offering or doing violence to me, contrary to FSS 843.01 (3rd Felony).

Based on statements, evidence, and my investigation, I find probable cause to believe that Zachary Salzer was intoxicated and endangered the safety of another person or property in a public place, and caused a disturbance, contrary to FSS 856.011 (2nd Misdemeanor).
