

I responded to 1317 South Federal Highway (Dunkin Donuts) in reference to a theft delayed. While enroute dispatch advised via radio the caller stated someone stole his bicycle. Upon arrival, I observed a heavily intoxicated white male yelling at the cashier in the establishment. I ordered the white male later identified as Zackary William Sousa (DOB: 01/29/1989) to step outside so I could talk with him. While speaking with Sousa, I could smell the heavy odor of alcohol coming from Sousa's person along with him having blood shot eyes and slurred speech. I advised Sousa that his bicycle was not stolen and that his bicycle was near the sidewalk on South Federal Highway. At this time Sousa got upset began to yell repeatedly "Come Here" and argue with me about his bicycle being stolen. I advised Sousa again that his bicycle is not stolen and he need to stop yelling and causing a scene in front of the establishment, Sousa replied very loudly "NO". I advised Dispatch via radio Sousa was intoxicated and creating a scene and to send me extra officers. While waiting for officers to assist, I ordered Sousa to sit down due to him not being able to maintain his balance as he constantly kept rocking back and forth. Officers arrived on scene Sousa was place in handcuffs (checked for tightness and double locked) and placed into the rear of a marked police department unit. It should be noted that prior to making contact with Sousa, there was a previous call from 1507 South Federal Highway (Sweetwater bar and Grill) complaining that Sousa was harassing and threatening customers. Sousa had left the area prior to my arrival.

Sousa was checked in FCIC/NCIC with negative results.

Based on the above stated facts, Sousa was arrested for Disorderly Intoxication in violation of FSS 856.011. Sousa was transported to Bethesda Medical Hospital by Officer Vargas Id #906 to be medically clear due to Sousa being extremely intoxicated. After Sousa was cleared by hospital staff, He was transported to BBPD booking for processing and taken over to Palm Beach County Jail.
