


On August 31, 2019 at approximately 0241 hours, while on routine patrol, I observed what appeared to be a disabled motor vehicle in the westbound outside lane of Palmetto Park Road at the traffic light of St. Andrew's Blvd in the incorporated city of Boca Raton. Upon turning my PBSO marked patrol vehicle around and parking behind the grey Ford 5 door, I advised PBSO dispatch of the Florida Tag # DCDE86. It began to approach the vehicle and Boca Raton Police also arrived on scene. At that time the vehicles brake lights were activated and all the vehicle's windows had condensation on the inside making it difficult to see inside. Through the front windshield I was able to see an unconscious white male with facial hair, at that time I requested for Fire Rescue to respond to the location.

I banged on the driver's side window in an attempt to get the driver's attention, that was initially met with negative results. I then attempted to open the driver's side doors and they were both locked. Myself and the Boca Police Officer Desiderato # 829, began to bang on the window's again on both sides of the vehicle and I saw a subtle movement by the driver. I attempted to open the driver's side doors again, at which time the subject took his foot off the break and fled westbound on Palmetto Park Rd. I advised PBSO dispatch of the driver's action and I attempted to conduct a traffic stop on the vehicle. Due to the driver's actions I was advised by the road supervisor not to continue my attempt of a traffic stop on the vehicle.

A NCIC/FCIC query of the vehicle's tag, revealed [REDACTED]

[REDACTED] Initial attempts to locate the vehicle at the residence were met with negative results. Based on the action taken, a probable cause exists pursuant to F.S.S. 316.1935(1) for fleeing and eluding. At 19:00 hours on August 31, 2019 Kramer was located at his residence and placed under arrest.
