**(Wednesday)** I responded to 3811 Victoria Drive In UnIncorporated West Palm Beach, Fl. 33406. Where I met with B/F Johnson, Destiney In reference to a disturbance.

Johnson stated on this date and time the father of her son B/M Correa, Christian called her via telephone to meet up with her by the pool house of the Somerset subdivision at the address listed above. Johnson said she was sitting in the passenger side front seat talking with Correra, when B/F later identified by her FL/DL as Walton, Za' Kisjah open the passenger side door and began punching her where she punched her on the right side of her face. Johnson stated she fought back to get out of the vehicle at which time she was able to run away and call for help. Johnson was able to provide a tag for the vehicle (CKV1042) that Correra was driving, which is the same vehicle Walton left in with Correra. The tag of the vehicle is a Black 2018 Chevy 4Dr registered to Walton located at 9292 shadow Wood Blvd. Coral Springs, FL. 33071. Johnson stated they left going South on Victoria Drive. Johnson provided me with a written sworn statement that this information is true.

While on scene with Johnson she received a text message of a snap chat video from a friend of this incident that Walton posted. I viewed the video and I observed Walton wearing a blue bonnet cap on her head, a pink/red shirt with gray and black tights. Walton walks up open the door and begins verbally trying to encourage Johnson to get out the car. When Johnson refused I observed Walton attack Johnson while she was sitting inside the car. I asked Johnson what caused this incident between her and Walton. Johnson stated they were once friends, however, she now believes Walton is dating Correra.

Johnson stated her vision was blurry and was treated on scene by PBCFR reference run#19-047376 engine#33.

Based on my investigation and my observation of the snap chat video. I found probable cause to charge Walton with Simple Battery pursuant to F.S.S. 784.03 1A1
