## PROBABLE CAUSE

On Friday, August 26, 2016, at approximately 11:58PM, I (Cpl. Waychowsky #1198) responded to 560 US Hwy 1 (County Line Plaza) in Tequesta, reference a drunk pedestrian. We were notified by the manager of Dollar General that the subject was walking west bound through the plaza.

Upon arrival, Myself and Cpl. Blanc #1187, made contact with the defendant, Zezar Kolombo. Kolombo was staggering while attempting to walk. He was holding a 4 pack of beer with two beers remaining. I explained why we were called out and he was slurring his speech and yelling obscenities. He attempted to leave the scene and go into his place of business. He stumbled and lost his balance.

Cpl Blanc and I attempted to detain Kolombo. As we were placing him in handcuffs, he pulled away and pushed our arms away. When he was grabbed, he resisted and struggled to keep his arms out of our grasp. He was yelling obscenities and making verbal threats to us, our Officers, and our families. We gained control of Kolombo and placed handcuffs behind his back and checked for proper fit and double locked them. We placed him in the rear of patrol unit 507, until we gathered further information.

I made contact with the manager of Dollar General ( Jay Ogden) while Cpl. Blanc stayed with Kolombo. Ogden stated He was outside his store when Kolombo was drinking a beer on his front bench. He could see he was already intoxicated. Kolombo went inside to use the bathroom. He was stumbling into the store with his beers. Ogden told kolombo he could not drink there and in the store. Kolombo became very aggressive and agitated and got in Ogden's face in front of customers and employees. Ogden told him to leave and called the police. Kolombo walked west through the plaza. Ogden completed a sworn witness affidavit.

Based on the witness statements and what Cpl. Blanc and I observed, I placed Kolombo under arrest for disorderly intoxication per F.S.S 856.011, and resisting arrest without violence, per F.S.S 843.01. Cpl. Blanc transported Kolombo to the Tequesta Police Station for processing. While at the police station. Kolombo kept yelling obscenities and making threats to law enforcement. I transported Kolombo to the Palm Beach County Jail for processing.
